

# CRS Practitioner apprenticeship

You'll gain knowledge and skills within Sustainability whilst obtaining a professional Corporate Responsibility and Sustainability (CRS) qualification.

You'll be enrolled on a **Level 4 Corporate Responsibility and Sustainability Practitioner Apprenticeship** which will be over a period of 30 months.

Hours of work will be 8:00am to 5:00pm Monday to Friday with a daily one-hour unpaid break (40 hours per week). Starting salary of £17,888 - £19,219 DOE, to be reviewed annually.

## About the Role:

The apprenticeship training is delivered through a series of online workshops and Microsoft Teams meetings with 1:1 calls with your learning coach as required, so you will need to be autonomous, proactive, and self-driven in your learning.

You will be responsible for helping innovate and drive ambitions for social and environmental change within the company. Assisting the SHE Manager (Safety, Health & Environmental) and Operations Director, you will work alongside internal and external stakeholders across multiple functions to create a cohesive and meaningful CRS strategy.

The main duties for this position include but are not limited to the following: -

- Assist in creating campaigns and contributing ideas on a CRS strategy.
- Assist in maintaining the businesses sustainability risk assessments and / or the aspect/impact database.
- Assist in the auditing of the business's sustainability processes to ensure continued compliance with statutory, regulatory and stake holders' requirements.
- To help develop, manage, and maintain the businesses sustainability KPI's.
- To assist in delivering training and toolbox talks to colleagues in relation to sustainability.
- To help identify and deliver new sustainability initiatives.
- To assist in maintaining our ISO 14001 and 50001 accreditations.
- Collect and review CRS data from across the business to support industry and mandatory reporting requirements.
- Ensure that all projects and campaigns meet regulatory standards.
- Build and maintain relationships with colleagues and external community organisations to drive positive social and environmental impact.

- Strong communication skills both verbal and written.
